III **Feature Presentation – Probation and Parole**

LaTonya Tate, MSJC, is a retired probation and parole officer, and founder and Executive Director of the Alabama Justice Initiative, an organization whose mission is to help people who face post-incarceration issues after being released from jails, prisons and the courts to transition back into society. She knows first hand the difficulties of reentry, as her recently released son from 20 years of imprisonment suffered post-incarceration issues after release on parole. LaTonya is a 2018 Soros Justice Fellow with a project focusing on the broken and arbitrary probation and parole systems. In this presentation she will highlight supervision sentences that stretch on for years and actually harm public safety by straining probation and parole resources and create trip wires that land people back in prison. Bernida Thompson, Ed.D In 1977 Dr. Thompson became the founding teacher and principal of the Roots Activity Learning Center and in 1999 the Roots Public Charter School where she demands excellence in cultural relevance and academics. She will share her personal story as the mother of a son who is the victim of indefinite detention - sex offender civil commitment.
